3. I DEVISE AND BEQUEATH all my estate both real and personal whatsoever and wheresoever (including any property over which I may have a general power of appointment or disposition by Will) which are located in Hong Kong to my Executor or Contingent Executor UPON TRUST to sell call in and convert the same into money with power to postpone such sale calling in and conversion thereof, so long as he/she shall in his/her absolute discretion think fit without being liable for loss.
4. My Executor or Contingent Executor shall hold my estate or the net proceeds of the said sale and conversion, any unsold property and my ready money UPON TRUST to pay thereout all my just debts and funeral and testamentary expenses.
5. My Executor or Contingent Executor shall hold my residuary estate UPON TRUST to absolutely pay each of my beneficiaries named in **the Schedule A** such residuary estate in such proportion of shares stated and described in **the Schedule B**, provided that such beneficiaries (or any of them) shall survive me.
6. I direct my Executor (or Contingent Executor) when applying for probate of this
